Commissioner Gaskill, Pct. 2, presided for the following business, to-wit:

**1. CONSIDER APPROVAL OF EMERGENCY REPAIRS TO PLUMBING AT THE JUSTICE CENTER.**

Commissioner Gaskill, Pct. 2, opened the Special Session at 9:00 A.M. to discuss the emergency repairs to the plumbing at the Justice Center.

Commissioner Acker informed the court that Jail Standards require a repair to be made within 48 hours which removes the option for going out for bids. Commissioner Acker also informed the court that the new repairs, due to the main sewer line collapsing would be at a minimum \$5,000.00 but could be over \$50,000.00 depending on what was found after the job was started.

Commissioner Acker made a motion to approve the emergency equipment repairs to the plumbing at the Justice Center in the approximate amount of a minimum \$5,000.00 but could be over \$50,000.00 depending on what was found after the job was started. Commissioner Simmons seconded the motion and all members voted "aye".

WHEREFORE it is ORDERED, ADJUDGED and DECREED that the emergency equipment repairs to the plumbing at the Justice Center in the approximate amount of a minimum \$5,000.00 but could be over \$50,000.00 depending on what was found after the job was started is HEREBY APPROVED.

Commissioner Gaskill, Pct. 2, presiding closed the Special Session at 9:15 A.M.
