Judge White opened the Public Hearing for the Revision of the Silverleaf Resort Condos, located within Section 4 of Holly Lake Ranch, Pct. 3.

Misty Goldman, County Commissioner's Office Manager, presented to the court a Revision of the Silverleaf Resorts located within Section 4 of Holly Lake Ranch, Pct. 3. Ms. Goldman informed the court this revision would known as Condo Phase 1, 2, 3, 4 & 5 and a Recreation Area. Ms. Goldman noted a letter of service was provided by Upshur Rural Electric to provide services to the condos and by Liberty Water & Sewer Services stating they will own and maintain sewer services and treatment facility. All documentation is completed which also included mailing 18 certified letters to touching and adjacent property owners with 12 of those letters being signed for and cards returned.

Several property owners from Holly Lake were present to ask questions and concerns. Mr. Eric Ho, Silverleaf Resort Condo property owner and requesting the revision of his property, answered questions related to the revision. Brandon Baade, Asst. District Attorney, spoke to some of the concerns and questions that were being asked about Holly Lake's HOA, parking, dues, entrances could not be answered or discussed by Ms. Goldman or the court due to civil matter between Holly Lake Ranch/board members and Mr. Hoe. The only business of the court was to approve the revision of the property as stated on the agenda.

Judge White closed the Public Hearing.

Commissioner Bowring made a motion to approve of the Revision of the Silverleaf Resort Condos, located within Section 4 of Holly Lake Ranch, Pct. 3, to be known as Condo Phase 1, 2, 3, 4 & 5 and a Recreation Area. Commissioner Simmons seconded the motion and all members voted "aye".
