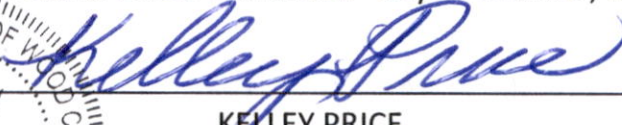
Judge White adjourned the meeting.
